




OUR MISSION



With the hopes of supporting the interest in STEM in low-income communities, SFIC is proud to announce the launch of the SFIC Futures In STEM Initiative.

The SFIC Futures In STEM Program aims to facilitate the educational and career paths of low-income students within the fields of Science, Technology, Engineering, and Mathematics (STEM). Through a robust scholarship award aimed at youth with an interest in science and mathematics, SFIC will help students from low-income families to attend fantastic private schools within their communities.

With the addition of a bi-monthly Mentoring/Tutoring Program, SFIC will also give the opportunity for any SFIC scholarship recipient to receive additional support as they strive for greater educational success.

Each program year will end with the SFIC Futures In STEM Fair, where kids who were part of the Mentor/Tutoring Program will share their experiences with the program and their thoughts on a relevant real-world application of STEM.

Throughout the year, SFIC will create conversations with community partners, businesses, and local universities that will allow field experts and professionals to guide students as they explore their self-directed reflection on the role of STEM.

Ultimately, the children we serve will become the future of their communities – serving as a new generation of scientists, engineers, researchers, and most importantly, role models of success.
